FINAL MINUTES OF PUBLIC MEETING

Board members present: Gail Cromwell, John Kieley

Call to order by Cromwell at 3:05 p.m.

Paperwork: Signed abatement forms for Marr/Hanson, M 07 L 039; Barrett, M 08 L 036; and Hagen, M 08 L 045-2.

Signed MS-1 extension request to the State of NH-DRA.

Signed extension request for the LEOP grant to Sept. 30, 2015.

Signed special event permit application for the Harvest Festival.

Signed letters to former volunteer Webmasters requesting domain information for new website.

Reviewed and signed vouchers.

Wolfe abatement: The Board reviewed the new recommendation from Avitar Associates made after an interior inspection was allowed. Move by Kieley to approve the Wolfe abatement, M 07 L 004, second by Cromwell and voted in the unanimous affirmative.

Town Forest Easement: The Board reviewed the baseline easement document for the Town Forest. Kieley suggested removing a sentence from paragraph IV. Cromwell suggested that paragraph VI should be changed to indicate that "hunting, cross-country skiing and horseback riding" would be permitted recreational activities. Kieley will email the changes to the Monadnock Conservancy. Kieley suggested that this document be signed after Selectman Willard returns, Cromwell agreed.

Minutes: Minutes held until the next meeting, Aug 26, 2014.

Miscellaneous: The Administrative Assistant asked the Board what they would like to do about the porch columns on the Municipal Building, which have rotted at the bottom and have been removed. Kieley suggested having Greg Ellis look at these and make suggestions. Cromwell agreed and Kieley will contact Ellis.

Cromwell updated the Board on the Joint Police Board meeting. The Town of Greenville has billed the Police Department \$4,000.00 more than was budgeted for 2014, claiming that their property/liability insurance has increased. Police Chief McTague has stated that there have been no claims associated with the Police recently. Kieley will contact Ron O'Keefe at PLIT and ask if O'Keefe can explain the increase. Cromwell also stated that Chief McTague has not been able to fill the part-time slot yet.

The Board discussed the SCBA purchase for the Fire Department. The board would like to have copies of the proposals for the SCBA. The Board will put a list together of information they would like to discuss with the FD at the 8/26/14 meeting, the A.A. will forward upon receipt from the Board.

Move by Kieley to adjourn, second by Willard, and so voted at 6:19 p.m.
