FINAL MINUTES

CAPITAL IMPROVEMENT COMMITTEE

Meeting held on February 8, 2011

Call to order at 7:35 p.m.

Connie mentioned that the Board of Selectmen (BOS) wish to meet with the CIP committee next Tuesday at 7:00. Some members may be available and will RSVP to BOS.

Doug commented on the correct use of email and the CIP committee policies voted on 5/25/10. All email (except minutes, spreadsheets, narratives, etc.) should be sent to the Chairman and he/she will forward to the committee if appropriate. If email is sent to the entire committee it becomes a public document and may be part of the minutes. Dave mentioned that multiple emails are considered a meeting and not acceptable by this committee. Connie has issues with the policies and wants to discuss it in the future.

Motion by Paul, 2nd by Mary Beth to accept the narrative as amended for the final version. Voted 6 affirmative, 1 abstained.

Alan will email the final version and create PDF files. Connie will make 50 copies at the town office. Doug will email the electronic version of the bridge inventory he received to the committee.

Discussion followed on future committee appointments and how the BOS will accept them. Sherry has submitted a letter of interest, Doug and Connie said they intend to submit letters also. A motion was made by Paul to reappoint Sherry, Doug and Connie. No $2^{\rm nd}$. A motion was made by Dave to leave more time for interested parties to submit letters. No $2^{\rm nd}$. No action taken.
