

Temple's Natural Resources Inventory was last conducted in 2003. In 2022, a review and update began, led by the Conservation Commission.

The Town of Temple contracted with Moosewood Ecological for Phase I of this 2-year project.

"Goals of this NRI project were to

- 1) Review and analyze existing natural resources data and reports,
- 2) Develop a series of updated NRI maps designed for educational and planning purposes, *and*
- 3) Combine the natural resources data and maps into this NRI report."

During this forum, residents will have an opportunity to review the DRAFT NRI report compiled by Moosewood Ecological and learn more about opportunities to participate in Phase II of this project in 2023.

Upon completion of both phases of this project, the Planning Board will hold a Public Hearing to consider adoption of the final report into Temple's Master Plan.

From the report:

"With the understanding that development will inevitably occur, Temple is faced with choices about directing growth and open space conservation so that a suitable balance can be achieved. Planning for the protection of open space is a critical and positive step towards solutions to these challenges."
