Select Board members present: G. Cromwell, B. Ezell, and K. Caisse  
Meeting called to order by Ezell at 6:30 PM

**69 Kullgren Rd Response**

- Kullgren Rd residents present at the meeting were given copies of:
  - The notice of violation
  - The letters from the Fire Chief and the Select Board to the property owner's mortgage company stating that the property is a fire hazard/illegal junkyard.
- Residents would like to have standardized guidelines in place to proactively handle situations like 69 Kullgren Rd that many arise in the future.
- Residents want zoning more strictly enforced.

- Motion was made by Cromwell to accept the recommendation by Tim Fiske, Road Agent, to hire Kent Perry at \$19.30/hr. Perry will start work at Fiske's discretion and will replace Steve Hruska who gave his two-week notice. Motion seconded by Caisse, all in favor.

- Joyce Kullgren resigned from her position of Deputy Tax Collector. Ezell motioned to accept her resignation. Cromwell seconded the motion, all in favor.
- Elizabeth Humphrey was appointed as Deputy Tax Collector by Tax Collector, Jeanne Whitcomb. Cromwell motioned to accept the appointment. Caisse seconded the motion, all in favor.

**Other Business**

- Select Board minutes for October 9<sup>th</sup> 2018 were approved with minor changes. Under the Police Budget, “will go up by \$18,000” was replaced with “would go up by \$18,000” and “separate pay rates” was changed to “give pay changes separately.” Under Town Hall Committee Report, “south side” was added to clarify which part of the church exterior was being discussed and “send notification of the changes” was replaced by “send information on the changes.” Cromwell motioned to accept the revisions. Caisse seconded the motion, all in favor.
- Building Permits Reviewed/Approved: Hagen, Cabana.
- Renewals of agreements with both Avitar and Primex were discussed.

  - Hastings provided a voting information notice to the SB. She will email it to the SB and Ezell will forward it to the webmaster. (see attachment)
