Warrant Articles

To the inhabitants of the Town of Temple, NH in the County of Hillsborough in said State, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Temple, on Tuesday, the Eighth Day of March 2016 next, at ten o'clock in the morning, to act on the following subjects.

Article 1: To cast your ballots for the election of all officers required to be elected to serve the Town of Temple for the ensuing year.

Article 2: To see if the Town of Temple, NH shall vote to adopt the provisions of RSA 40:13 (known as SB 2) to allow official ballot voting on all issues before the Town of Temple, NH on the second Tuesday of March. (3/5 majority vote needed) (By petition).

Article 3: To cast your ballots on the proposed amendment to the Temple Zoning Ordinance to add Section 31 "Commercial and Industrial Noise".

Article 4: To cast your ballots on the proposed amendment to the Temple Zoning Ordinance to Revise Section 17: Signs, paragraph (e); delete existing paragraph (e) and replace with new language.

THE POLLS SHALL OPEN AT TEN O'CLOCK IN THE MORNING, AND SHALL CLOSE NOT EARLIER THAN SEVEN O'CLOCK IN THE EVENING.

You are further notified to meet at the Temple Elementary School in said Temple, on Saturday, the Twelfth Day of March 2016 next, at ten o'clock in the morning, to act on the following:

Article 5: To see if the town will vote to raise and appropriate the sum of \$1,330,816.00 for town charges as the operating budget and other necessary maintenance and operating expenditures. (Selectmen recommend)

Article 6: To see if the town will vote to raise and appropriate the sum of Thirty Thousand dollars (\$30,000.00) for the purpose of removing asbestos and demolishing the building located at 400 NH RT 45 (taken by the Town of Temple by tax deed in 2015.) (Selectmen recommend)

Article 7: To see if the town will vote to raise and appropriate the sum of Twenty Thousand dollars (\$20,000.00) for the purpose of repairing the Hadley Highway Bridge. (Selectmen recommend)

Article 8: To see if the town will vote to raise and appropriate the sum of Eleven Thousand dollars (\$11,000.00) for the purpose of repairing old headstones in the town cemeteries, with \$10,000.00 coming from the Cemetery Lots Fund and \$1,000.00 from a grant approved by the 250th Anniversary Committee. (Selectmen recommend)

Article 9: To see if the town will vote to raise and appropriate the sum of Five Thousand dollars (\$5,000.00) to be placed in the Asphalt/Paving Expendable Trust Fund previously established by Article #4, March 12, 2010 Town Meeting under the provisions of RSA 31:19-a. (Selectmen recommend)

Article 10: To see if the town will vote to raise and appropriate the sum of Five Thousand dollars (\$5,000.00) to be placed in the Culvert and Bridge Maintenance and Repair Expendable Trust previously established by Article #7, March 15, 2014 Town Meeting under the provisions of RSA 31:19-a. (Selectmen recommend)

Article 11: To see if the town will vote to raise and appropriate the sum of Four Thousand dollars (\$4,000.00) for the purpose of purchasing a propane tank for the Library/Highway Department heating needs. (Selectmen recommend)

Article 12: To see if the town will vote to raise and appropriate the sum of Thirty One Thousand dollars (\$31,000.00) as additional funds to be added to the Police budget for the purpose of re-establishing a Police Department within the Town of Temple. This anticipates the expiration on March 31, 2016 of the Inter-municipal Agreement between the Towns of Temple and Greenville for the provision of Police Services. (Selectmen recommend 2 to 1)

Article 13: To see if the Town will vote to authorize the Selectmen to enter into a 2 year inter-municipal agreement for provision of police services pursuant to RSA 53-A with the Town of Greenville on such terms and conditions as specified in a contract approved by the Attorney General's Office. This article is contingent upon passage of a similar warrant article by the Town of Greenville. (Majority ballot vote required) (Selectmen recommend)

Warrant Articles

Article 14: To see if the Town of Temple, NH will vote to oppose the installation of a natural gas pipeline as part of the Northeast Energy Direct project by Tennessee Gas Company LLC, a Kinder Morgan Company.

- a. Whereas, the release of contaminants from drilling will jeopardize our aquifers, drinking water and wetlands.
- b. Whereas, the known emissions of toxins related to the compressor station as well as, blow-downs will impact the health of town residents.
- c. Whereas, the proximity of the compressor station to Temple's Elementary School, also used as Temple's Emergency Shelter, will not only impact the health and safety of the students but in the event of a pipeline related catastrophe it will also impact the town's ability to provide an emergency shelter.
- d. Whereas, the town's lack of equipment or personnel to respond to a pipeline explosion, leak or other malfunction emergency will endanger the safety of our residents.
- e. Whereas, this project will negatively impact town property values.

The Northeast Energy Direct project threatens a healthy living atmosphere for both residents and wildlife and violates the Temple Master Plan to "protect the health, safety, security, and welfare of all inhabitants of Temple" (Town of Temple Master Plan 2003, p.89).

Article 15: To see if the town will vote to raise and appropriate the sum of Two Thousand dollars (\$2,000.00) to cover air testing equipment and analysis to establish baseline air quality in the vicinity of the proposed compressor station for the Kinder Morgan/Tennessee Gas Pipeline Company's Northeast Energy Direct pipeline. (*Selectmen recommend*)

Article 16: To see if the town will vote to dissolve the Budget Advisory Committee established by vote on article 21 of the March 16, 2002 Town Meeting. (*By petition*)

Article 17: To see if the town will urge: that the Congress and President, as well as the NH Legislature, take concrete steps to fight big money politics and restore government to the people, including the following measures:

1. Overturn Citizens United;
2. Ban Super PACs;
3. Require that all political donors' names be made public; and
4. Establish small-donor, citizen-funded elections.

The record of the vote approving this article shall be transmitted by written notice from the selectmen to the NH congressional delegation and to Temple's state legislators, and to the President of the United States informing them of the instructions from their constituents within 30 days of the vote and again to those elected to office in November 2016. (*By petition*).

Select Board Report

The year was dominated by the newly proposed Kinder Morgan Pipeline that would be sited along our common border with Greenville and New Ipswich and create a significant hazard in the construction and operation of a massive 41,000HP Compressor Station. The Board created a special committee, the Temple Ad-Hoc Pipeline Advisory Committee, to study and advise our select board and town on the issues and possible responses to this proposal. We are indebted to the committee for their work and particularly the advice they have produced over the year. Several important forums were held to inform our residents on various aspects of the pipeline, beginning with general information, then an informative session on state regulations and finally an expert presentation on the health effects of compressor stations. Many of our residents attended and spoke with authority and passion at the regional "scoping sessions," sponsored by the Federal Energy Regulatory Commission (FERC), the agency responsible for the ultimate decision. Our town is also a member of the Municipal Pipeline Coalition, a consortium of 15 towns fighting the pipeline. Finally the town is an "intervenor" with FERC, and we will do whatever we can to (1) fight the pipeline and if that fails, (2) minimize its effects.

For the first time in a number of years, the town took a property for the non-payment of taxes. The owner had died and there was no interested descendant. The property is conveniently located across the road from our present town offices and may be useful in the future. It connects to the town land on General Miller Highway.

For the first time ever, later this spring, the town will accept credit and debit cards for the payment of all taxes and fees EXCEPT property taxes. (We may add that later.) This will be for motor vehicle registrations, dog licenses, and an assortment of other items that go through the Town Clerk and may be done online or at the town office. This is not free so we urge everyone to consider it carefully. It is intended entirely as a convenience to our taxpayers, and you can always pay with checks and cash at no extra cost. We will not be ready to begin this until most likely April. A further announcement will be made at that time.

We had good news in the purchase of the new loader: a lower price (\$117,500) and good financing terms (3 years at 2.5%). In addition, grants were

received to cover the "Jaws of Life" (by the Fire Department) and the Stryker Power Stretcher (by Wilton-Lyndeborough-Temple Ambulance Association).

Several projects were finally completed: both Converse Road bridges, the new Employee Manual, and satisfactory resolution of several significant zoning violations. Building permits were issued for three new homes and several home businesses were approved. The Jeta Grove Monastery was approved as a 501C(3) organization with a promised payment in lieu of taxes (PILOT).

Capital Improvements Program Report

The New Hampshire legislature established RSA 674:5-8 to encourage towns to develop Capital Improvement Plans in order to anticipate and plan financially for major expenses. Temple's first Capital Improvement Plan (CIP) was developed in 2004 with assistance from all of the Town's Departments. The resulting plan was intended to be a living document that would be updated each year to reflect the town's changing needs. The CIP has updated that plan in each subsequent year providing recommendations to the Select Board for consideration at Town Meeting.

The CIP committee's goal is to try and keep the Capital Improvements budget as flat as possible, while emphasizing protection of current infrastructure and town services.

In 2015/16 the CIP Committee met and/or communicated with each town department reviewing and discussing all potential revisions for the 2016-2025 CIP Plan. To assure continuity of discussion from year to year each department also provides a *CIP Expenditure Request Form* as well as up-to-date written quotes for all items requested.

This year the CIP Committee also had discussions regarding both capital reserves and grants:

Capital Reserves: An unavoidable cycle in Highway Department equipment has three large vehicle replacements in 2020, 2021 and 2028 (totaling approx. \$509,000). The Fire Department also has two large vehicle replacements due in 2023 and 2026 (totaling approx. \$515,265). In order to avoid future tax spikes the CIP committee approved a recommendation to the Select Board that the Town place warrant articles for substantial amounts to be deposited in a Capital Reserve for Capital Equipment starting in 2019. (see chart on following page)

Grants: Beginning with 2016 we are formally requesting that each Department research and apply for all available grants in the year prior to the year that a capital expense is requested. Temple's Fire Department, Highway Department and Municipal Office have had great successes being awarded grants and the CIP wishes to encourage early applications so we can better plan for a smooth bottom line.

A copy of this year's CIP reports (including both the Narrative and Spreadsheet) may be picked up at Town Meeting or at the Municipal Building.

For 2016, the ongoing bond payments are:

Fire Department: 9 Air Packs, Air Cylinders, and Booster were purchased in 2014: The price was \$62,500 but due to a generous anonymous donor contribution of \$5,000 the cost to the town was reduced to \$57,500. This amount was financed for 5 years at 2.29%. The 2016 payment of **\$12,454** will be the second of 5 payments. Interest paid over the 5 years will be \$3,410.

Highway Department: The 2014 International Dump Truck was purchased in 2013 at a cost of \$160,258 and financed at 2.15% for six years. Total interest will be \$12,128. The 2016 payment of **\$29,045** is the third of 6 payments.

Highway Department: The 2015 Loader was purchased in 2015 at a cost of \$117,500 and financed at 2.15% for three years. Total interest will be \$5,875. The 2016 payment of **\$42,104** is the first of 3 payments.

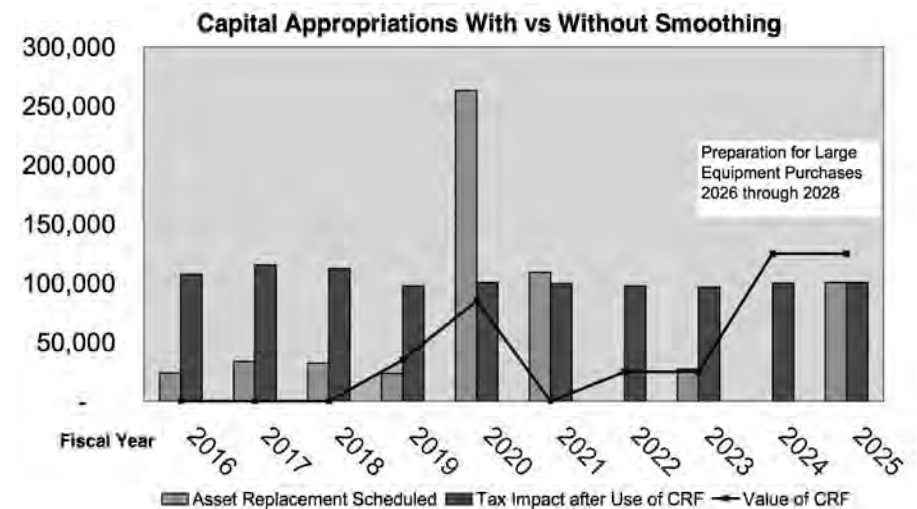
For 2016, the CIP Committee recommends the following projects:

Highway Department: The CIP recommends a warrant article of **\$20,000** to repair the Hadley Highway Bridge #1 in 2016.

Recreation Department: The CIP recommends a warrant article of **\$4,000** to repair the tennis and basketball courts.

Budget Advisory Committee

The Budget Advisory Committee (BAC) provided the Temple Board of Selectmen (BOS) with a recommended operating budget of \$1,227,119 exclusive of \$83,607 for previously committed debt service and any warrant articles that may be approved at Town Meeting. This is \$32,681 less than the approved budget for 2015 and does not include possible increases for town employees. (Such adjustments are left to the discretion of the BOS.)

The BAC is most appreciative of time and assistance provided by the department heads, the elected and appointed boards, the vibrant volunteers of various committees and the valuable input provided by the municipal administration team.

The up-coming issues we are obliged to highlight relate to:

1. The instability of energy prices and their impact on the gas, diesel fuel, electricity costs and the income from recyclables. We have cautiously lowered line items where deemed appropriate.
2. The pending contract renewal of the Temple-Greenville Police Cooperative (T-GPC.) Our submitted budget assumes that the contract will be continued by both communities (and this is our recommendation.) As a contingency, the BAC has worked with the BOS, and the police chief, to prepare a Temple standalone budget to be effective for the remainder of 2016 should the T-GPC not be continued.

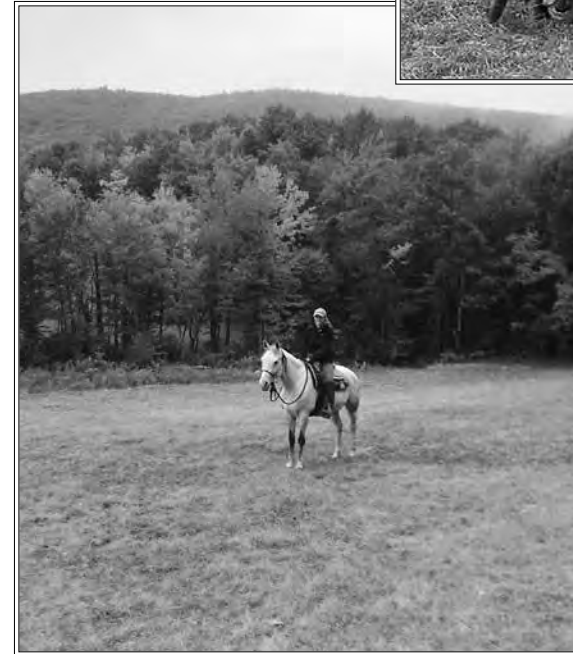

Highway Department

For the record, January 2015 was what I call a typical January; cold with several small snowstorms, icy, and some rain. On the other hand, February was a bit extraordinary. We had close to 8 feet of snow from January 28 to February 28, and it was very cold and windy. This kept us very busy to say the least. March was here before we knew it and the snowstorms subsided and the temperatures started to warm up. We still had a few snowstorms and some freezing rain, but the snow slowly disappeared leaving us to deal with the mud.

The frost went down very deep under the roads due to the very cold temperatures. This made the gravel roads dry out quite slowly which delayed the grading of the roads until April. Old Man Winter had to take one more stab at us of course with an inch of ice pellets and freezing rain on April 8th. Things calmed down after that and we continued with our spring grading and ditching.

The month of May was one of the driest on record with only about ½ inch of rain all month. The lawns started to burn and the gravel roads became dry and dusty. Cold River Bridge Co. came back and we worked with them to do the finishing touches on the Converse Rd. Bridge #1. They placed the Riprap (the rock rubble used to prevent erosion) along the stream banking, had the guardrails installed, and landscaped around it. We finished our own springtime work and on May 18th, we purchased a new “zero-turn” lawnmower. Our new mower did not get much use until June when it finally started to rain again and the grass began to grow.

Much of our time in June, July, and August was spent working on West Rd. Our new CAT loader was delivered and we put it right to work:

- All of the ditches and culverts were cleaned
- Several very large trees that were too close to the road were removed
- The section between Stone Ln. and Blood Rd. was ground up
- 550 ft. of underground drainage was installed and an old rotted out culvert was replaced
- Approximately 1500 tons of gravel was hauled in and used to build the road bed up about 12 inches
- Advanced Paving Co. came in and repaved the section that had been ripped up then continued with the top coat all the way back to the center of town
- The remainder of West Rd. was patched with some sections shimmed, then we sand sealed from Blood Rd. to the Sharon town line.

The weather throughout the summer was quite pleasant; some rain but not excessive, warm temperatures but not hot. The gravel roads held up very well so our fall-time grading went well. We piled up our winter sand, widened a section of Memorial Hwy., and cut down some dead trees. We then got our snowplows and sanders ready for winter.

The weather in November continued to be nice so we spent quite a bit of time cleaning up leaves and pine needles in the cemeteries, the Town lawns, and the ballpark. December arrived but winter did not. We had the warmest December ever recorded. No skiing. No white Christmas. It was 60° on Christmas Day! We cut and chipped up a lot of roadside brush and low-hanging limbs. The year ended with a couple of inches of sleet and some freezing rain on December 29th.

In the summer of 2016, we will be spending a lot of time working on Mansfield Rd., Hill Rd., Cutter Rd., and Moran Rd. ditching, paving, sealing, etc. We plan to pour a cement bottom into the large culvert/bridge on Hadley Hwy. between Hill Rd. and Mansfield Rd. There will be a Warrant Article asking for \$20,000 for this project. The cost of a new bridge would be around \$500,000 but pouring the new cement bottom should extend the life of this bridge for another 30 years. Please try to avoid the construction areas when possible and drive slowly through them if you need to drive that route.

The Temple-Greenville Police Department has been in existence for eleven years. Throughout that time we have worked hard to make both towns a safer place in which to live. I am very proud of the men and women who have made this a reality. However, as you are aware, there is a heroin addiction issue in our country, state, and towns. The majority of our court cases involve drugs and/or alcohol in some form. We, as a department, are working to prosecute these cases in order to get the help that these people need.

This upcoming year the Towns will be asked whether or not to renew the combined Police Department contract. Citizens from both towns have asked me, "Should we continue the merger?" As with many hard questions the answer is, "it depends". The merger was put in place to solve Greenville's and Temple's police issues. The Town of Greenville sent out a letter asking neighboring towns for assistance with their lack of a Police Department. The Town of Temple was facing the issue of an inadequate police station. Both towns were looking for a way to reduce their costs, reduce crime, and improve their coverage. The merger has done that.

If the towns were to breakup, these issues would return. The towns, however, may be in a better position to address their individual issues. I know that every town is different in what it wants from its Police Department. The officers, administrative assistants, and I all wish to stay neutral on this. We want the towns to do what is in their best interest.

Town of Wilton Ambulance Service

In 2015, there has been an increase in call volume with a decrease in response times, new drivers coming aboard, providers upgrading their levels of training, and taking a hard look at our budget. We have done this all with our mission in mind of providing the best prehospital emergency care to the citizens and visitors of the towns of Wilton, Lyndeborough, and Temple.

In 2015, the Town of Wilton ambulance had a 4% increase in call volume over 2014. We average 1.3 calls per day. Our response times (dispatch to scene) are down by 7.1% or 52.8 seconds from 2014. This is thanks to the hard work and dedication of the EMS providers on the service. Many stay at the station to keep response times down.

We have had an influx of driver/non-medical personnel last year. We presently have three volunteer Drivers. They supplement the crew as a third person. This gives them exposure prior to attending EMT Class. This program has been in place since 2012 and has been very successful. Presently we have 4 EMT's that started as drivers, of which one is attending Advanced EMT class.

Our staff is also advancing their careers. In 2015, EMT/Captain Robert Cole successfully completed his Advanced EMT. We presently have three providers (EMT Jennifer Hagerty, EMT Belynda Morgan, and EMT Jeff Rychwa) attending Advanced EMT class. They should be online in the second half of this year. We also have three drivers anxiously waiting to take their EMT Class. This will greatly enhance our staffing at the EMT/Advanced EMT level.

In 2015 our revenues were 14% above projected revenues, and we were below budget on our expenditures. This, along with a hard look at our 2016 budget, we are asking for a more than 10% decrease from the towns. We appreciate the support that the three towns give us.

As we have said in past years, thank you for your support over the past year, and in the future, we do appreciate it. We are also always looking for members, and you don't have to have any medical experience, we will train you. If you're interested, give us a call. We'd love to have you on board.

Temple Town Forester

For the tax year April 1, 2014 through March 31, 2015, the Town received seven Reports of Wood or Timber Cut. Yield taxes assessed for these harvesting operations totaled \$3,089.87. As of January 11, 2016, three Intents to Cut have been filed with the Town for the current tax year. Timber harvesting operations have been fairly quiet in town over the past year as can be seen by the small number of Reports of Cut and current Intents. Good quality white pine and hardwood continue to be in demand. The pulp market has had a significant down turn which will probably continue for much of the year. This has resulted in an oversupply to the chip plants which is starting to cut into prices. In spite of even lower oil prices this winter, the demand for firewood continues to be strong.

The State RSA specifies that any person owning land upon which wood or timber is cut, either for sale or for services rendered, must first file an Intent to Cut form with the Town Selectmen or assessing officials. The exception to this is a person cutting up to 10,000 board feet of logs or up to 20 cords of fuel wood for either their own use or for a land conversion. Under these exceptions an individual does not have to file an Intent to Cut form. The tax year runs from April 1st to March 31st.

The RSA also states that within 60 days of completion of the operation or by May 15th, a Report of Wood or Timber Cut must be filed with the Town specifying the exact volume cut by species. The Town will levy a 10 percent yield tax based on the stumpage value of the material cut. This value is not based on the actual price paid for the forest products but on average values provided by the State. If the job is not completed by March 31st or did not take place, a Report of Cut must still be filed by May 15th. At that time a new Intent to Cut should be filed to renew the permit. If the job is not completed by March 31st but will be completed by June 30th, a 90-day extension may be granted without having to renew the permit. To do this the Selectmen must be notified in writing by the Owner, prior to May 15th. Finally, during a harvesting operation, if the volumes to be harvested are going to exceed the estimated volumes on the original Intent to Cut, a supplemental Intent should be filed immediately showing the additional estimated volumes.

Landowners considering a timber harvest should be aware that there are State harvesting regulations that must be followed. If you have any questions regarding this or the permitting process, you can contact me through the Selectmen's Office.

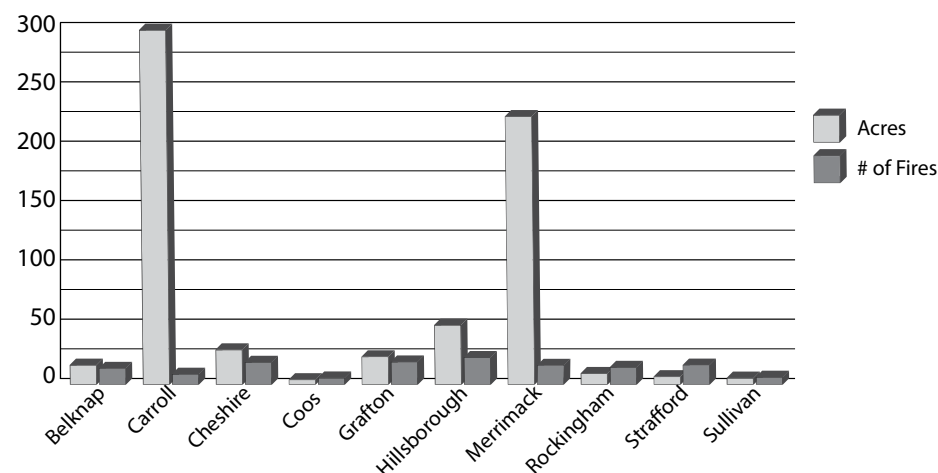
Your local Forest Fire Warden, Fire Department, and the State of New Hampshire Division of Forests & Lands, work collaboratively to reduce the risk and frequency of wildland fires in New Hampshire. To help us assist you, please contact your local Forest Fire Warden or Fire Department to determine if a permit is required before doing ANY outside burning. Under State law (RSA 227-L:17) a fire permit is required for all outside burning, unless the ground is completely covered with snow. The ability to obtain fire permits on line was initiated in 2015. Approximately 120 towns participated in the online system with over 4,000 permits issued. To obtain a permit on line visit www.NHfirepermit.com. The New Hampshire Department of Environmental Services also prohibits the open burning of household waste. Citizens are encouraged to contact the local fire department or DES at 603-271-3503 or www.des.state.nh.gov for more information. Safe open burning requires diligence and responsibility. Help us to protect New Hampshire's forest resources. For more information please contact the Division of Forests & Lands at (603) 271-2214, or online at www.nhdf.org.

This past fire season burned **661 acres** which was the most recorded since 1989 when 629 acres burned. The fire season began in early April with the first reported fire occurring on April 8th. The largest fire was the 275 acre Bayle Mountain fire in Ossipee. This fire started on May 5th and burned for several days. The Bayle Mt. fire was also the largest individual fire in NH in over 25 years. There were also a number of other sizable fires in May which definitely kept NH's wildland firefighting resources stretched to the limit. These larger fires increased the average wildland fire size to 5.12 acres. As usual our higher fire danger days correlated well with the days that there were fires actually reported. The statewide system of 16 fire lookout towers continues to operate on Class III or higher fire danger days. Our fire lookouts are credited with keeping most fires small and saving several structures due to their quick and accurate spotting capabilities. The towers fire spotting capability was supplemented by the NH Civil Air Patrol when the fire danger was especially high. Many homes in New Hampshire are located in the wildland urban interface, which is the area where homes and flammable wildland fuels intermix. Several of the fires during the 2015 season threatened structures, and a few structures were burned, a constant reminder that forest fires burn more than just trees. Homeowners should take measures to prevent a wildland fire from spreading to their home. Precautions include keeping your roof and gutters clear of leaves and pine needles, and maintaining adequate green space around your home free of flammable materials. Additional information and homeowner recommendations are available at www.firewise.org. Please help Smokey Bear, your local fire department, and the state's Forest Rangers by being fire wise and fire safe!

Planning Board

After the election in March, newly elected members Bruce Kullgren, Jr. and Ted Sartell were welcomed to the board, as was new ex-officio member George Willard. The following slate of officers was voted in to serve for the year: Chairman – Allan Pickman; Vice Chairman – Randy Martin; and Secretary – Ted Sartell. We also send out a special thank-you to Randy for his dedication, having served 24 years on the Planning Board.

During the year one application for subdivision of property was received and approved. Also, the board received and approved two requests for a lot line adjustment, plus one request for a lot line merger:

Agriculture: In January a public hearing was held to discuss proposed zoning amendments concerning agriculture. This was well attended, and residents provided a lively dialogue. After taking comments and suggestions into consideration, the board made some revisions and then held a second public hearing. It was finally decided to put forth one amendment that would require agricultural buildings over a certain size go through an abbreviated Site Plan Review process. This proposal was defeated by voters in March. Another outcome from the dialogue about agriculture was a plan to form a committee made up of diverse members to provide advice on agricultural issues.

Buddhist Forest Monastery: A unique matter that came before the board was a request for Site Plan Review to establish a monastic residential community on 240 acres of property in the north end of town. Jeta Grove Foundation had previously obtained approval from the town's Zoning Board of Adjustment that would allow them to modify existing structures, and also build 'kutis' or individual huts in the forest where each monk would live. After a public hearing in March, the Planning Board granted Site Plan Review approval.

Master Plan update: This project was undertaken starting with research and discussion on how best to structure the revision, and some progress was made. However, progress was interrupted, primarily due to the need to address other important issues affecting the town. It is hoped the process will resume during the upcoming year.

Site Plan Review update: The Board added new site plan review regulations for Large Scale Infrastructure Construction, Utility Transmission and Distribution Construction, and Industrial Construction. These will help mitigate damage and disruption of any new large scale projects. Many thanks to George Stoltz for his efforts in helping draft these regulations.

Gas pipeline: By far the most significant issue the board dealt with this year was the specter of Kinder Morgan's proposal to build a fracked gas pipeline through many nearby towns. Temple chose to become involved when the route indicated a huge compressor station could be sited on the Temple/New Ipswich town line, very close to the Temple Elementary School and Tobey Reservoir. Residents and officials of towns and cities across the state began to research and share information about this industrial project. Alliances were formed by municipalities to provide a voice and group resistance in the hope of deterring government approval that would allow the project to proceed. Monitoring this pipeline project will continue to remain an important issue in the upcoming year.

My thanks go to board members and to Betsy Perry for all their hard work and dedication during the past year.

Conservation Commission

Conservation Commission began 2015 with three project in its sights:

The first project was developing a policy for activities on town conservation lands.

The second project involved identifying and inventorying farmland and working with landowners and farmers to help sustain diverse agricultural activities, healthy lands, and a pool of new farmers for the future.

The third project involved engaging our children and the Temple Elementary School in field trips to farms and forests. The Conservation Commission wanted to propose a Conservation Day that would involve children, teachers, and parents in outdoor activities that help maintain our open spaces, plants and animals, and natural systems.

Unfortunately the implementation of these projects was prevented due to the announcement of Kinder Morgan's Northeast Energy Direct (NED) pipeline project in the winter of 2014/2015. Since that announcement, the Conservation Commission members have been busy with efforts tracking the project and pursuing ways to protect the natural resources of the town from potential damages due to the NED project.

The Conservation Commission, along with the Selectboard and many town citizens commented on the NED project to the Federal Energy Regulatory Commission (FERC) for docket PF14-22-000. Additionally, the Conservation Commission, along with the Selectboard and many town citizens intervened in the project to the Federal Energy Regulatory Commission (FERC) for docket CP-16-21.

Along with 30 other NH Conservation Commissions, the Temple Conservation Commission registered concerns with the FERC regarding the NED pipeline's potential threat to natural resources. A letter and document was sent to the FERC and Governor Hassan. The entire letter and document can be found on the Temple Town website. Below is a brief summary of the major points the Conservation Commission made opposing the pipeline.

Conservation Commission Letter re: NED

Impact on Water Resources

NED has the potential to adversely affect groundwater and surface water along the proposed route. Both resources are of great concern.

- Well contamination from nitrites or nitrates introduced during blasting.
- Well contamination from previously bound naturally occurring pollutants (such as arsenic and radon) released by blasting.
- Loss or reduction of well output through changes in bedrock channels caused by blasting. (Many private wells are bedrock wells, although the exact proportion of wells fed from bedrock aquifers and stratified drift aquifers is unknown.)
- Contamination through prolonged herbicide use to control vegetation along pipeline and compressor station.
- Contamination through fluids leaked from construction vehicles operating in wetlands and above aquifers, or fluids spilled during fueling or maintenance.
- Direct disruption of hydrology through soil disturbance (dig and fill), particularly in wetlands where necessary soil layering takes centuries to develop and is difficult to recreate once disturbed.
- Direct disruption of hydrology through changes in topology, affecting runoff patterns and rainwater accumulation needed to recharge aquifers.
- Direct drawdown of aquifers due to hydrostatic testing that might require more water than many of these aquifers normally produce.
- Erosion and sedimentation during construction of water crossings affecting fish and stream

Impact on Future Conservation Efforts

The NED pipeline will cross at least 34 conservation properties in 15 New Hampshire towns. Putting a large pipeline through legally conserved lands is highly problematic, if not illegal by NH state law. Most of the conservation land being crossed by this project was acquired either by gift or by fee purchase authorized by the relevant towns. The protection of this land was made possible by citizens, voters, and donors who believe strongly that New Hampshire's natural environment is worth protecting now and for future generations.

Impact on Wildlife Habitat

Healthy fish and wildlife populations that support traditional activities such as fishing and hunting depend on New Hampshire's highest-ranked wildlife habitat. The compressor station will likely discourage wildlife in the entire region.

Impact on Air Quality

Potential adverse effects on air quality come in two forms:

1. Direct release of methane into the atmosphere, and
2. Tons of air pollutants released at the compressor station as a side effect of burning hydrofractured gas to provide power to power the compressors. Many medical professionals have found exposure to anticipated levels of these pollutants will increase respiratory problems and rates of cancer.

Noise Impacts

The compressor station on the New Ipswich border will abut the southern Temple town line. Federal guidelines require a maximum day-night average noise level for compressor stations of 55 dB. Along with the 24x7 noise of 41,000 HP compressor turbines, there are occasional extremely loud blowdowns. Many Temple residents live within range where the 24x7 compressor noise will be audible.

Construction Impacts

In addition to the construction-related issues already described, construction activities can trigger additional adverse effects including:

- Introduction of invasive plants through plant materials inadvertently brought to the site on construction equipment or within fill material.
- Fugitive dust and diesel exhaust from trucks and heavy equipment on roadways (southern New Hampshire has many miles of dirt roads which are often the only means of access to planned construction sites). Both pollutants contribute to or exacerbate respiratory problems.

This summary is not an exhaustive list of the problems with the NED pipeline, for example having no social/economic benefits. These points are the major concerns the Temple Conservation Commission has relating to the protection of Temple's natural resources.

Temple Economical Energy Committee

The Energy Committee had its hands full in 2015. Along with recycling for Town Meeting, Good Roads Day, the 4th of July celebration, and the Harvest Festival, and pitching in on the recycling for TES, we had an informative booth at the Harvest Festival, updated environmental information on our website, www.teec.info, and again joined the Recreation Committee in sponsoring a solar project for the 3rd and 4th graders at TES. But we were compelled to focus the majority of our time on researching and then opposing the Kinder Morgan natural gas pipeline, which is proposing to blast and bulldoze its way through conservation lands, water resources and the neighborhoods of 17 southern NH towns.

The solar project at TES: We began by engaging the students in a spirited classroom discussion about the value of harnessing the sun and the wind to power our homes and buildings. Then the after-school science teacher, Mr. Lechner, guided the kids in the age-appropriate, simple electronics of building miniature solar-powered vehicles. Our students get a kick out of making and racing them every year out in the parking lot on sunny day in spring, and each year seem more knowledgeable about how the kinds of power we use effect our climate and the habitats of some of their favorite animal species.

Energy efficiency and solar referrals. The committee continued to provide residents with guidance and referrals for home energy efficiency upgrades and solar installations for their homes and property. And the committee awaited the results of the 8-town RGGI grant application we had participated in initiating to facilitate the installation of a large net-metered solar array. It would have powered some of the municipal buildings in each participating town. Unfortunately, our state legislature reduced the amount of funding available, and we were not awarded the grant. But we will apply again.

Opposing the pipeline. By far, the largest efforts for TEEC in 2015 were researching information about natural gas pipelines and educating our community about the massive Kinder Morgan/Tennessee Gas Pipeline Company's Northeast Energy Direct (NED) pipeline proposal for New England. If approved, it will have serious effects on our state, region, and Temple. In spite of the fact that the pipeline, itself, is not slated to run through Temple, it will be right on our

border, go over our largest aquifer and construct its most problematic and onerous component dangerously close to our school and residential neighborhoods.

Since the mission for the Energy Committee is to work toward reducing greenhouse gas emissions, as was established by the passage of a Warrant Article at the 2007 Town Meeting, we have had the job of informing our residents that natural gas is methane, a more provocative greenhouse gas for escalating climate change than other fossil fuels. It has been incorrectly called a "cleaner fuel" or a "bridge fuel". It is not. And Temple's Master Plan includes an Energy Chapter which recommends ongoing efforts to work toward more sustainable and clean energy usage. So our committee is tasked with opposing the \$5 billion investment in the enormous natural gas pipeline which would commit our state to predominantly fossil fuel usage for decades, rather than moving in the direction that will help moderate the effects of climate change, or support the gradual movement to clean, renewable resources.

In the spring, we were asked by the Select Board to create a voluntary committee that would advise the board on steps it could take to address the potential challenges the pipeline could present for our town. Since then, the Energy Committee's work and the pipeline resistance efforts have unified. The non-partisan Temple Ad Hoc Pipeline Committee has been meeting weekly, advising the Select Board, gathering information to be posted on the new pipeline page of Temple's website, and meeting with residents from other towns to work together on various coalitions to resist the NED. We organized a series

of 5 large educational events, three in Town Hall and two at the school, each with a different focus. We produced slide shows and numerous hand-outs with information on all aspects of the pipeline; distributed “No Pipeline” signs; wrote letters to FERC, Kinder Morgan and our legislators; sent representatives to meetings with our state and congressional legislators and to PUC, SEC, and legislative hearings. We spoke and presented our written statements of concerns at FERC Scoping Sessions, Kinder Morgan Open Houses, Conval School Board meetings, and NH legislative sessions. We informed residents of actions they can take to help resist the harms to our health and the safety of our aquifers, wells, eco-systems, wildlife, real estate values, tax base, and way of life.

Once we discovered that a 41,000 horse power compressor station would be sited on our border with New Ipswich, a mere ½ mile from our elementary school and close to the reservoir which provides the school’s and Greenville’s drinking water, our research intensified. We learned from numerous well-documented studies that compressor station emissions are not only toxic and contain radioactive substances but are particularly hazardous for young children and the elderly. So, we initiated a petition authorizing Temple to file for intervener status to enable the town to take legal action with FERC to help protect our school children. It was signed by the vast majority of residents who attended the 2015 Town Meeting. Since then, hundreds of Temple residents joined in signing the petition to our governor that was presented to her office during an anti-pipeline rally at the State House, in December, with the signatures of over 10,000 citizens from all over the state, asking her to protect NH and say NO to the Kinder Morgan pipeline.

More avenues of this work are being put into effect weekly. Help from our citizens is critical. Writing Letters to the Editor, writing letters and sending emails to our legislators about our health concerns for our kids at TES is an especially powerful and ongoing need. We need to make them accountable. We will not give in. We are determined

Temple Town Hall Advisory Committee

The Temple Board of Selectmen (BOS) established the Temple Town Hall Advisory Committee (TTHAC) in 2010 to act as stewards of this town building, supporting the BOS in an advisory capacity.

The primary purpose of the TTHAC is to assist in monitoring the use and condition of the Town Hall, advising the Select Board on any issues arising that might impact the building's functionality or appearance. This will ensure that the facility remains a vibrant community center for education, enrichment and general enjoyment, and that its historic, functional and financial values are protected on behalf of all current and future Temple residents. Additionally, this will assist the Town in fulfilling its obligation to preserve the Town Hall in the same structural condition and state of repair as when its rehabilitation was completed, in accordance with but not limited to, the terms of the Stewardship Agreement that exists between the Town of Temple and the NH Land and Community Heritage Investment Program (LCHIP). Extending beyond the LCHIP agreement timeframe, the existence of this advisory committee will ensure that the same spirit of Town Hall stewardship is carried forth, and that the preservation of this building continues in perpetuity.

As part of the four-year painting plan, bids for repainting the Town Hall's front exterior were solicited this spring, at which time extensive rot was discovered in the columns at the library-side entrance to the Main Hall. The columns were repaired in July, and the front exterior wall painted in September. A very special thanks to Dick Benotti for repairing and repainting the Town Hall's bulletin case!

We conducted our annual inspection of the Town Hall's interior and exterior in October, a process required to complete the "LCHIP Historic Resources Annual Monitoring Report". Poor condition of the building's north side exterior was noted, and will be remedied by painting scheduled for 2016. We prepared the "2015 LCHIP Historic Resources Annual Monitoring Report", which was approved by the BOS and submitted to LCHIP on November 25th.

During December, in accordance with the Town's "maintenance as needed" plan, the hall's oak floor was sanded and a fresh coat of polyurethane applied.

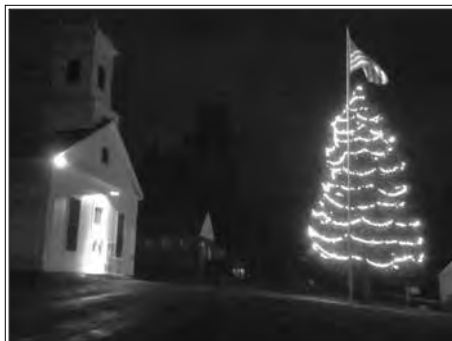

Village Green Committee

250th Anniversary Fund

The Temple Anniversary Fund is happy to announce it will distribute its 2015 award to the Cemetery Trustees for the purpose of restoring gravestones in the Wives and Mothers and East cemeteries.

The Fund was established in 2008 with an initial gift of capital with the intent of inspiring other donations so that substantial projects, outside of those we vote on in Town Meeting, could be envisioned and carried out. Each year, about \$1,000 is awarded to projects in town that are of benefit to all. The Fund is still able to receive additional gifts which will enable the committee to increase the amount we can give to local projects. Donations to the Anniversary Fund are held by the NH Charitable Trust. More information on making a donation is available at the Town Offices.

Over the past seven years, the advisory committee has recommended a variety of worthy projects to the Select Board for consideration. Projects selected include furniture for the library, repairs to the town common, plantings, playground equipment at the school, restoration of an historic portrait, and more. This year the money will honor those who came before by restoring the grave markers in cemeteries for all to visit, read, and remember.

Through the volunteer Driver Program:

- we assist in sustaining and/or improving the health and well-being of riders
- our Volunteer Drivers provide access to essential healthcare, support services, and other basic needs for those who are unable to drive because of age, ability and/or income level.
- we enhance our riders' ability to reclaim, retain, or attain independence by providing for themselves and their family.

We project 57 ride requests from Temple residents in 2015 out of a total of 1,694 requests for all 13 towns.

The big news is that CVTC is assuming the American Red Cross - Keene Chapter volunteer medical transportation program for the entire Monadnock region over the next few months. Red Cross will continue to focus on their core services of emergency preparedness, response and recovery; service to veterans; and maintaining an adequate blood supply. CVTC is pleased to ensure the continuation of this valuable service.

The transfer of services will take place in two phases, starting in the 13 towns of the Eastern Monadnock region on January 1, 2016. 28 Red Cross Drivers from the Eastern Monadnock region have already signed up to drive with CVTC and will join our drivers to cover ALL trips Monday through Friday. The full transfer, including the Western region towns is expected on or before July 1, 2016.

Now entering our seventh year of service, CVTC is a strong thread in the safety-net of human services and continues to advocate for community transportation options for the entire region.

On behalf of our riders and volunteer drivers, we hope the Town of Temple will continue supporting CVTC's efforts with a donation of \$500. Monadnock Family Services is actively serving residents of the Town of Temple through the provision of quality mental health counseling and rehabilitation services to anyone who needs them—regardless of their ability to pay. In addition to being the region's only emergency mental health crisis service, MFS offers a variety of treatment programs for our community. Our Adult Outpatient Services program provides mental health evaluation and treatment, as well as medication evaluation and monitoring, counseling and specialized group services. Our Child, Adolescent & Family Services program is designed to support and promote good mental health in children and every member of the family. The Monadnock Substance Abuse Services program helps people develop new, healthier behaviors and make positive changes in their lives. Our broad array of services to residents of Temple also includes the Monadnock Volunteer Center, InSHAPE for Adults and Children, Supported Employment and the Monadnock Adult Care Center.

Your ongoing support of our work is deeply appreciated, and we hope that our partnership in caring for the residents of Temple will continue. We pursue many other sources of funding, such as the Monadnock United Way, grants and additional fundraising efforts conducted in concert with our Board of Directors. Each source, however, helps with only a portion of the total cost of care.

We thank you for your many years of financial support and ask for your continued allocation to help underwrite the cost of services we provide to the uninsured and underinsured individuals in your community. In FY 2015, MFS provided over **\$14,639** in discounts to the consumers in Temple. We expect that an additional **\$5,322** will likely be written off as uncollectible. To help close this gap, we are asking for the equivalent of **\$1.25** for each resident of Temple which, based on the 2010 US Census, amounts to **\$1,708**. St. Joseph Community Services, Inc.

For many years, the Town of Temple has supported our services. I write again to ask for your continuing support. St. Joseph Community Services has been providing vital services to the elderly and disabled adults of Hillsborough County for thirty-eight years. Providing nutrition and social engagement to this often isolated population helps support their choice to remain independent and age in place in their own homes within their communities. For many of our homebound clients, the driver may be the only person he or she will see that day.

Meals-on-Wheels is not an entitlement program. In other words, there is a limit to the amount of meals funded under our state contract. The funding that we receive from the cities and towns in our service area of Hillsborough County is essential to our ability to continue to meet the needs of everyone who asks for our help.

In addition, our program is funded by the state on a per meal basis. The money provided for each meal does not cover the full cost of a meal. It was never intended to. It is expected that agencies like St. Joseph Community Services would raise the remainder of the funds from the communities it serves.

Last year, we served **8 Temple** residents. **One** of these **8** residents were served under our Title XX program, which is sponsored by the County of Hillsborough. We are requesting funding of \$80 for each of the remaining clients.

Before any structure or dwelling may be occupied, all inspections must be completed and a certificate of occupancy issued by the Selectmen. (Passage recommended by Planning Board.)

Your property may qualify if two or more lots were merged for zoning, assessing, or taxation purposes and the merger occurred:

- During your ownership, without your consent; or
- Prior to your ownership, if no previous owner consented to the merger

To restore your property to pre-merger status, you must:

- Make a request to the local governing body
- No later than December 31, 2016

Once restored:

- Your properties will once again become separate lots; however, they must still conform to applicable land use ordinances. Restoration does not cure non-conformity.

INDEPENDENT AUDITORS' REPORT
