(Reported by Honey Hastings) Aaron Abitz of Katsura Landscaping has accomplished a lot since the May Trustees' meeting. Becky, Honey, and Cam (not more that 2 at a time) have met with Aaron several times, conferred about the progress to date and more to come. After plant removal, weeding, and installing new plants, the foundation planting on south side (pre-existing plantings) and the east side, and the east slope have been mulched for moisture and weed control.

The east side foundation planting includes 5 blueberry bushes and some perennials. Cam has been watering the blueberries and recently purchased slow-watering "donuts" for them. The concrete top of the former time capsule location was an unplanned find. It is very heavy and will be left in place.

Many plants were removed from the east slope and the area was weeded. Plants for pollinators and 3-season color were installed. He plans on another smaller round of thinning and planting in a

month or so. Two reasons to put off further work: 1) some of the plants (such as yellow fox glove) are blooming now and 2) the very hot temperatures expected in early June.

Road Agent Kent Perry accepted our offer of the removed plants and has been planting them in the Wives & Mothers Cemetery and other town locations

The planters now have lavender petunias from Julie McAdoo, a few purchased annuals, and lots of marigolds that grew from the seeds of last summers' flowers.
