The Board agreed at the 6/3 meeting to review and prepare to discuss three documents Christine sent to them following the 6/3 meeting: Maps from the Temple Hazard Mitigation Plan, the Fluvial Erosion Report, and the NH Flood Insurance Map. That discussion has been postponed to the 8/4 meeting. Since the floodplain proposal is a zoning issue requiring hearings and voting, this discussion should not be put off for a long period of time.

e. Innovative land use (Christine)

Christine was going to share an electronic copy of the New Hampshire Planners Association Conference (6/23 or 6/24) when she received it. The concern Board members have raised is whether proactively addressing exclusionary housing issues in town would be preferable to state intervention mandating workforce or affordable housing. A question to address is whether Temple should invite a developer to respond to a Request For Proposal (RFP) with their ideas.

f. Future land use section of the Master Plan: add to fall agenda in fall, with better understanding of Temple's economic situation as a result of Covid-19.
