II. Approval of Draft Minutes

III. Old Business

A. Community Engagement Town Ball Field July 4th 2023

Flyers were handed out at the special town meeting. Ivy has received the postcards this afternoon and will take them to the post office to be mailed to Temple residents.

IV. New Business

A. Mason's Site Plan Review/Lot Line Adjustment/Subdivision Application Process

Everyone agrees that having a chart like Mason's would be helpful for applicants to understand what needs to be completed. Russ provided feedback on having separate sections for boundary and adjustments. He also provided feedback that major and minor subdivisions should have a decision tree of what you need and don't need. The planning board has other changes to incorporate and will review with Russ in more detail.

Once the planning board does a deep dive on these, we will review it again (likely August/September)

V. Housing Needs Assessment

This is a document for this committee and will support the Master Plan Population and Housing chapter.

lvy shared how communities can achieve more housing naturally by turning large homes into multi-families and adding accessory dwelling units. She also shared information about the "Missing Middle" building types that are smaller than a bigger apartment building but house more people. For instance, cottage court, duplex, ADU's, triplex, small condo associations all fall into this category. She will send a whitepaper she has written on this topic to the group.

Sean shared that the options that are appropriate for Temple seem to drive people closer, environmentally there are also options to push them closer together. There is overlap with the work Moosewood Ecological is doing and we may want to work together on this in the future as we look at zoning.
