Agenda to include:

- 1. Meeting called to order at 7:00 PM by Vivian Wills and stated that the meeting was being held electronically pursuant to Executive Order 2020-04, Section 8, Emergency Order #12, Section 3.
- 2. Discuss application for CARES Act Fund
 - a. Vivian reported that the time frame to submit all of the information and get Select Board approval to pursue this grant would not be in time.
- 3. Discuss plan for Movie Night on the Common
 - a. Dan suggested trying to get approval for this event to be held next to the Town Hall. Vivian agreed. The building could serve as a secure back drop for a screen and we could access power from the TH.
 - b. The Common would provide more space for more people and proper distancing but more difficult to set up.
 - c. Ask SB permission to use the TH front hall handicapped bathroom with supervision, order a porta potty, or not provide a restroom option at all.
- 4. Discuss Open Mic on the Common
 - a. Dan suggests that this event can resume either next to the Town Hall or on the Common.
- 5. Finalize plans and write up proposals of each for Select Board approval
 - a. Vivian will write a draft proposal for approval and present at the August 25 SB meeting. We will abide by what the SB permits.
 - b. Final proposal presented to the SB is attached.

The Recreation Commission requests to hold an outdoor movie night on Saturday September 5 at 7 PM. We propose to hold this event on the lawn facing the Town Hall and using the side of the building wall as a way to hang a screen backdrop for projecting the movie onto. Designated spots for family groups maximum of 6 people spaced at a minimum of 6 feet apart will be marked ahead of time. Separate entrance and exits to the outdoor space will be posted and lighting provided. A maximum of 40 guests will be accepted at the event.

Access to the Town Hall in order to use electricity will be needed for the use of power cords of sound and audio equipment.

Support help from volunteers and committee members will assist and ensure that best practices of social distance as required by the town are upheld. Disposable face masks, latex gloves, sanitary wipes and hand disinfectant will be available to ALL participants to encourage their use as recommended by the CDC and other health agencies and our town officials.

The Recreation Commission also proposes this location to restart the Sat night Open Mic event. Upon approval the dates will be set and announced. Access to the Town Hall in order to use electricity will be needed for the sound equipment. The suggested format for this restart of Open Mic is to hold the event for a maximum of 2 hours. Those people wishing to perform will be given a predetermined time slot with a specific number of minutes allowed for their chosen pieces.

Further recommendations as deemed necessary by the Select Board to this proposal will be heeded by the Recreation Commission.
