- 1. Approval of June 10 minutes.
 - a. Draft minutes read and discussed.
 - i. **Action** Vivian made a motion to approve the Minutes from June 10. Dan seconded. Motion passed unanimously.
- 2. Welcome to new member Gretchen Whitcomb
 - a. Vivian and Dan discussed the history of the Temple Rec through the years especially with focus on Joe Cournoyer's service to the town on this committee from its beginning. The list of all current RC events and programs held was given as described in the recent document for the publication being prepared by Linda Bollinger for residents of Temple. One change to note is that the Monadnock Mountain Music Jam held on 2nd Sundays of the month and has just resumed has renamed the event as Temple Mountain Music. Also, some discussion about the Halloween event to come was approached about the Trunk or Treat and the 2020 change to door to door Trick or Treating due to Covid. We will make a final decision about what 2021 will be at the next meeting. It is likely that the Celebrate Temple event might not happen and we will also wait to hear from TES about the Thanksgiving dinner for seniors.

The RC finances were explained as the two accounts we have to expense from. The Revolving Fund established in 2010 at Town Meeting with the passing of the Warrant Article and the town approved budget for funding the major events held during the year. Vivian will email to Gretchen the information about these accounts and as much info about the RC as possible.

Our email account and Facebook page were discussed as well as the Temple NH website page for the RC. Gretchen can help with some of the Facebook functions.

 - a.
