Agenda to include:

- 1. Meeting called to order at 7:30 PM by Vivian Wills and stated that the meeting was being held electronically pursuant to Executive Order 2020-04, Section 8, Emergency Order #12, Section 3.
- 2. Approve minutes
  - a. Action Vivian made a motion to approve the Minutes from November 5. Dan seconded. Motion passed unanimously pending amendment made to item #3 to include changes of decrease to projected expenses for holiday parties and \$400 funds to upgrade AV equipment.
- 3. Review of 2020 events.
  - a. Discussion RC members feel the best was done under the circumstances of effect of pandemic.
  - b. Discussion Due to increase of virus instances the ideas for Santa activities were not able to be acted on.
- 4. Plans for movie nights in 2021.
  - a. Discussion This item tabled until next meeting when any plans for Easter are discussed and spring and daylight savings time will be here.
- 5. Projected budget for 2021 and new equipment needed.
  - a. Discussion Vivian reported that the BAC agreed to the amount requested. There was question raised at the meeting about whether the AV upgrade costs could be taken from our Revolving Fund. This is not the type of expenditure that the fund would cover. Vivian spoke with Peter Allen, Temple Treasurer, to verify this and he confirmed. Vivian sent an email to Gary Scholl, BAC Chair, to explain this and included the document from the Municipal Assn specifying the rules and purposes of the revolving fund.

#### 6. Proposal for virtual yoga class from Kittie Perullo.

- a. Discussion Vivian reported that Kittie Quinn Perullo was in contact with her and expressing interest in holding a virtual yoga class via Zoom for the community. Vivian attended the Select Board meeting on Tuesday Jan. 12 to present this idea and they are supportive of the Rec Cmte moving forward with a plan.
- b. Discussion Vivian will announce this proposed activity on the Rec Facebook page and share it to the Temple, NH page as well. We hope to hear input from possible interested people for what time of day and type of activity is most popular.
- c. Discussion Vivian will send an email to all people organizing activities that the Rec Cmsn sponsors to offer them a time to present their events on the Zoom platform.
- d. Action Vivian made a motion that she would prepare a draft of the writings of an announcement and letter to be approved via email communication. Dan seconded. Motion passed unanimously.

#### 7. New business.

- a. Discussion Vivian presented a draft version of the Rec Cmsn committee report for the 2020 Annual Report. Dan suggested some rewording and otherwise stated it was fine.
  - i. Action Vivian made a motion to accept the final version of the report for submission. Dan seconded. Motion passed unanimously.
- b. Discussion Vivian reported that the wording of the Warrant Article passed in 2010 to establish the Revolving Fund needs to be amended. It reads, "The money received from fees and charges for recreation programs and donations shall be allowed to accumulate from year to year, and shall not be considered to be part of the Town's general fund". However, placing donated money into the fund is contrary to the NH state statute RSA 35-B:2. Vivian will request to be on the next Select Board meeting agenda (Tuesday January 26) to resolve this and also establish a way for donations to be placed in trust.
- c. Discussion Dan suggested that the RC schedule a date and time to compile an inventory of items stored in the Town Hall and what AV equipment it holds.

## **Copy of approved Recreation Commission Annual Report**

The year 2020 for the Recreation Commission started out with great enthusiasm and energy garnered from the successful programs held the year before. We give boundless thanks to the many townspeople and those in administrative positions who generously gave time, energy, resources and support to what is ultimately for the benefit of our beautiful town of Temple.

On the wings of this wind we laid out the groundwork for the year ahead with preset meetings to keep in motion our regular events and engaging with the leaders of regularly scheduled activities. Our committee began with the foundation of three dedicated members and some expressed interest to join the committee from others. By mid-March, this energy was turned around with the onset of the Covid-19 global pandemic that changed the face of our personal lives on every level.
