New Business:

- <u>Renewable Energy:</u> Rob Wills updated the board with what is going on with the Community power coalition and what the next steps are. Wills noted there were agreements that needed to be signed along with the approval of policies, and there needs to be an appointment of an Authorized officer. Wills noted someone from CPCNH will be at the next meeting to answer questions. Wills added that Legal should review the documents and they would also like the board to give provisional approval prior to town meeting.
- Drama Club Microphone proposal: Steve Cullinan noted the Drama club had an estimate of \$2965.00 for additional stage microphones which he believes will benefit the town for years to come. Ezell noted there is no ARPA money left and added they can budget this for next year. Cullinan wanted the equipment for the upcoming spring show. Ezell noted they can speak with the BAC and see if they can find any extra money in the 2024 budget. It was suggested Cullinan check with East West and see if they can even fit this in the schedule and even have the mics in stock.
- <u>Legal Opinion request 2019 Conval Warrant article:</u> Nicole Concordia requested that our legal counsel issue and opinion on whether the 2019 Conval Warrant Article referenced below is binding upon the school board or whether it is advisory only. Ezell moved to have legal review warrant article 10 from the 2019 Conval School warrant articles as discussed. Willard seconded, all were in favor, motion passed.
