CAC Broadband Committee

Created in 2019 as a subcommittee of the Community Advisory Committee (formerly known as the Temple Community Planning Committee.

- Tasked with researching and proposing solutions to Temple's Broadband inequity, advising the Select Board on finding a resolution.
- Meets with the CAC and as needed, until Broadband service is town wide.

Capital Improvement Plan Committee (CIP)

Formed in 2004 by vote at Town Meeting.

- Its purpose is to examine and develop an ongoing plan for capital expenditures (defined as projects or equipment costing more than \$5,000 with a useful life of 5 years). By creating such a plan, it allows the Town to anticipate major expenditures through budgetary forecasting, thus resulting in a more stable cost of town government. The CIP, when coupled with the Master Plan, allows the Town to monitor the impact of future development. This plan is a living document, being revised and re-evaluated on an annual basis.
- Typically meets twice a month from September to January, during budget season, on the 2nd & 4th Wednesdays of the month at 7 PM, adjusted for holidays.

Conservation Commission

Conservation commissions are local conservation volunteers who work to study, protect and improve natural resources.

- Currently working to improve trails on town lands, acquire new conservation lands, and introduce educational speakers at local events.
- These active volunteers are studying natural resources and developing long-term plans and strategies for the protection of important places, they are providing educational programs & hikes, they are working to permanently protect land, they are managing town lands for timber production, recreation and wildlife, they are researching the latest tools and advising other boards on the importance of the town's natural resources, and they are able to work with the state's Department of Environmental Services to provide local comment on wetland permits.

Historic District Commission

An ordinance establishing the Temple Historic District was approved at Town Meeting in 1982.

An ordinance establishing the Temple Historic District *Commission* was approved at Town Meeting in 2008.

- Within the Temple Historic District, it is the particular purpose of this ordinance to preserve and safeguard the heritage of the Town of Temple by the designation of a district which:
 - Reflects elements of its cultural, social, economic, political and architectural history.
 - Conserves property values in such district.
 - Strengthens the Historic District for the education, pleasure and welfare of the citizens of the Town of Temple.
- Temple has an unusual historic district in that only certain houses are part of the district.
- Commission shall have not less than 5 members, not more than 7, plus one associate member. At least one member must be from the Historic District, and one must be a Select Board member.
- The Historic District Commission is currently seeking new members.

Town Hall Advisory Committee

Committee was formed when the Town Hall restoration was completed to fulfill its obligation to preserve the Town Hall in the same structural condition and state of repair as when its rehabilitation was completed, in accordance with but not limited to the term of the Stewardship Agreement that exists between the Town of Temple and the Land and Community Heritage Investment Program (LCHIP).

- The primary purpose of this committee is to assist in monitoring the use and condition of this building, advising the Select Board on any issues arising that might impact the Town Hall's functionality or appearance. This will ensure that the building remains a vibrant community center for education, enrichment and general enjoyment, and that its historic, functional and financial values are protected on behalf of all Temple residents.

Zoning Board of Adjustment

Every town in NH by statute has a ZBA for residents who have issues with the town zoning ordinances.

- The Zoning Board of Adjustment (ZBA) is authorized under RSA 674:33 to:
 - Grant variances from the Temple <u>Zoning</u> <u>Ordinance</u>, including dimensional requirements;
 - Make special exceptions to the <u>Zoning</u> <u>Ordinance</u> as authorized in the ordinance (this includes approving certain business uses);
 - Hearing appeals of administrative decisions made by Board of Selectmen and other Temple land use boards in enforcing the <u>Zoning Ordinance</u>.
- It is a 7 person board, with 5 full members and 2 alternates. If a full member has to recuse themselves, then alternates are called on to fill in. Currently there is one opening.

Budget Advisory Committee

Two open positions in 2021.

- Our primary mission is to work annually with the town departments, committees, and boards to prepare and propose a Town Budget for approval by the Board of Selectmen in February and ultimately by the tax payers at Town Meeting in March.
- Works closely with CIP committee, which looks at larger purchases.
- From time to time the Select Board calls upon the BAC to provide various financerelated recommendations and consultations.
- Meets twice a month from September through February, adjusted for holidays, and as needed throughout the year. Meeting times vary to accommodate department/committee/town staff schedules.

Cemetery Trustees

- RSA 289:6 I requires every municipality to elect a board of cemetery trustees consisting of 3 members.
- One of the duties of the Cemetery Trustees is to adopt regulations for the management of all municipal cemeteries.
- Another duty of the Cemetery Trustees is to prepare an annual budget for the support and maintenance of the municipal cemeteries.
- In Temple, the Road Agent is the Cemetery Supervisor and the highway department staff covers cemetery and funereal duties and general maintenance.

Library Trustees

- A group of citizens to whom the public library is entrusted. The trustees are vested with the entire custody and management of the library.
- They select a librarian (often called the library director), adopt policies to govern the library's operation, and work for adequate financial support of the library.
- They have the power to expend all funds provided to the library, and determine how they will be spent.

Select Board

- The Select Board has unique statutory powers to administer the operations of the town, including authority to "manage the prudential affairs of the town."
- Some duties include (See RSA's 41:8 to 41:15)
 - Financial Duties
 - Establishment of Fees
 - Employee Candidate Background Checks
 - Regulation of Use of Highways, etc.
 - Manage Town Property
 - Enforcement of Regulations
 - Regulations; Permitting
 - Publishing the Town Report
 - Acquisition or Sale of Land, Buildings, or Both
 - Adoption and Amendment of Town Codes and Ordinances
 - Property Tax Rates
- Select Board members also serve on other boards and committees.
