

Temple Community Planning Committee (TCPC)
FINAL MINUTES
Thursday, November 19, 2020, 7:30 PM
Via Zoom per Gov. Sununu Emergency Orders #12 & #16

Attendees: Christine Robidoux, Dana Nowell, Jessica Hipp, Ivy Bibler, Vivian Wills, Bill Torphy, Bill Walker (guest)

The meeting was called to order at 7:00 p.m. Christine Robidoux read the State Of Emergency text. Attendance was taken via roll call.

The minutes from October 15, 2020 meeting were unanimously approved.

Jessica Hipp gave an update on the two broadband proposals received from Comcast and CCI. The subcommittee will host a broadband forum via Zoom to discuss the proposals on December 10, 7:00 p.m.

Vivian Wills reported that the Recreation Commission is planning an event for Christmastime. Plans for supporting kids and families in town will be revisited in 2021.

Christine Robidoux gave an update on the draft results from the Planning Board's Community Survey Results. A hearing is scheduled for Tuesday, Dec. 1 to present Zoning updates. These are corrections to existing zoning to put the town in compliance with State regulations.

The Land Use committee will meet again after Thanksgiving and present to the SB recommendations for a number of lots in town.

Ivy Bibler updated the committee on plans for the message board. Town Hall Advisory committee is working on some modifications to Tom Hawkins' initial proposal. The Village Green Committee will also be consulted. Once all feedback is gathered, Ivy will ask Tom to update the design and price. After there is a final design, it will ultimately go to the SB for approval.

The committee discussed a town logo, and how this would impact the design of the sign and other town related materials. Several logos and graphics have been used by various committees, however the town does not have an official logo. The committee discussed possibly creating a sign without a logo initially and adding one at a later date. The committee also discussed engaging Plan NH or local artists to design a logo.

Christine re-opened discussion of changing the name of the Temple Community Planning Committee. The current name is wordy, and the word "planning" is sometimes confused with the Planning Board. The committee recommends changing the name to the Community Advisory Committee. Christine will take this recommendation to the Select Board.

The meeting adjourned at 8:28 p.m.
